2. GENERAL TERMS OF SALE

2.1. Cooking lessons enrolment:

Contact directly the **A LA CARTE** Company to confirm your enrolment.

2.2. Taking of orders for made-to-measure gastronomic events (cooking lessons, gastronomic discoveries and home receptions):

All orders are definitively registered solely after receipt of written and signed confirmation together with a down payment of 50% of the total amount of the order, inclusive of taxes.

2.3. Modifications:

All modifications to the orders will be taken into account solely if they are made within a minimum deadline of 48 hours prior to the date of delivery of the order. The customer must compulsorily confirm all requests for modifications in writing.

2.4. Cancellation:

Cancellation of the order by the customer does not give rise to any return of the down payment paid which is kept as a lump sum indemnity. All cancellations made less than 48 hours prior to the scheduled date gives rise to the invoicing of 100% of the amount of the order.

2.5. Prices:

The prices are those given on the tariff applicable from January to December 2006. Transport costs are invoiced over and above.

2.6. Delivery:

Transport costs will be invoiced over and above and calculated in compliance with the prevailing tariff.

2.7. Mode of payment:

The **A LA CARTE** Company accepts several means of payment:

- most of the international credit cards,
- cheques in Euros to the order of 'A LA CARTE',
- cash in Euros only.

Terms of payment are as under:

- the cooking classes are payable on the spot before taking part in the class,
- made-to-measure gastronomic events (gastronomic discoveries and home receptions): down payment of 50% of the amount of the order, inclusive of taxes, when placing the order, the balance payable in cash on receipt of the invoice.
- all sums which not paid on the due dates indicated on the invoice shall give rise ipso jure (and without prior notice) to late payment penalties at a rate equal to one and a half times the legal interest rate.

2.8. Claims:

The customer must ensure that the delivery complies with his order. All claims concerning invoicing may be taken into account solely within an eight-day time limit following the date of the invoice.

2.9. Liability – Insurance:

The **A LA CARTE** Company has full civil liability cover. The customer is solely responsible for physical and/or consequential damages caused by him within the scope of the cookery classes carried out in the **A LA CARTE** workshop. In this respect, a certificate of insurance covering the damages sustained by the customer, as well as those caused by him, must compulsorily be enclosed with the registration file.

2.10. Force Majeure:

The **A LA CARTE** company may be released from the fulfilment of its obligations or suspend their execution if it is not possible for it to carry them out for force majeure reasons (illness of the Chef or the teacher in charge of the classes, war, demonstration, strike, traffic jam or difficulties, damage sustained by or accident having arisen in the facilities of the **A LA CARTE** company).

2.11. Disputes:

In the absence of amicable agreement, all disputes shall be settled by the Court of Paris entertaining jurisdiction in the area of location of the **A LA CARTE** company's registered office, the said Court alone holding competence in this respect.
